The Switched-On Management (SOM), Switched-On Selling (SOS) and Switched-On Network Marketing (SONM) Seminars are dynamic training programs on the cutting edge of 21st Century technology using Brain Gym® movement exercises. These seminars are practical and exciting hands-on training experiences that integrate the left and right hemispheres of the brain. This integration enables a manager, salesperson or network marketer to "switch on" their central nervous system for each step in the management, selling and network marketing processes, creating an internal fusion for greater business effectiveness and success.

All three seminars were developed by Dr. Jerry V. Teplitz and are based on the work of Dr. Paul Dennison in the field of Educational Kinesiology. Dennison's methods were originally developed as a means of correcting learning disabilities and have been found to be applicable in a wide variety of situations. Research studies conducted on several of these Switched-On Seminars have shown very dramatic changes in performance and success.

Instructor Training and Licensing Program

You can become a licensed Instructor of any or all of these seminars through the INSTRUCTOR TRAINING PROGRAMS. Both Switched-On Selling and Network Marketing seminars and Instructor Certifications are taught at the same time. Switched-On Management is taught as a separate training class. These Instructor training programs are designed to insure that Instructors can become skilled professionals able to address their clients in an effective manner while clearly presenting the seminar material. To fulfill this purpose, we have established a training program that will give all Instructors: a complete understanding of basic Educational Kinesiology processes, the Switched-On seminars, and effective training techniques and marketing materials.

Three Steps For Instructor Licensing:

- **I.** Decide if you want to be certified to teach one, two or all three seminars.
- II. Attend and successfully complete each three-day Instructor Training Course (Keep in mind the Selling and Network Marketing Certification Training programs are taught at the same time while Management is taught as a separate three-day program).
- III. Conduct and audio-tape the Switched-On Seminar for 5-6 people within 9 months of completion of the three-day training program. One taping will count towards both the Selling and Network Marketing Certifications. A separate taping must be done for Management. If you have not completed Step III within 9 months, you will need to repeat Step II.
 - (1) Submit the tape for feedback to Jerry Teplitz Enterprises, Inc.
 - (2) After evaluation by Jerry Teplitz Enterprises, Inc.
 - (a) You may be required to repeat the Instructor Training Course.
 - **(b)** You may be required to repeat Step III.
- **IV.** After a successful evaluation of Step III, you will be licensed as an Instructor through Jerry Teplitz Enterprises, or you will be counseled as to other necessary steps.
